- 5) The Azerbaijan Netherlands Business Hub reserves the right to cancel an application if the applicant fails to provide the information required for the smooth running of the organization in time.
- 6) The Azerbaijan Netherlands Business Hub enters the personal data provided by the applicant into a client database.
